UUA Religious Education Credentialing Committee Meeting Précis April 1 – 4, 2008 Boston, MA

The meeting convened at approximately 9:00 am on April 1, 2008.

The minutes from the March 2007 meeting were approved, with typographical corrections. Action items and reports from Gail Forsyth-Vail, Beth Miller, and Beth Williams were reviewed.

<u>Accessibility Issues</u> – The RECC meeting was open to the public from 9-11 am on Friday, April 4.

A/O-A/R Issues

The committee members read the essay, "The Courage of Our Contradictions: Perspectives on a Time of Trauma" from *Stations of the Spirit* by Victor Carpenter and watched "The Wilderness Journey." Bill Norris facilitated a discussion of the implications of the issues raised by both the book and the video for how the RECC does its work.

The committee discussed the pay equity issue which exists for credentialed vs. long-term non-credentialed Religious Educators, and also discussed the issue of whether the Master's Level Credential requires excessive work for the financial benefits it provides to those who are credentialed. This sentence

<u>Candidate Awards</u> – The following candidates were awarded Credentialed Religious Educator status: Lynn Hunt and Karen LoBracco.

<u>Credentialing Process</u> – The RECC delegates to the RECP Director the decision on granting Hold status to candidates, including those who are currently inactive, for pastoral issues that are not emergencies.

<u>Equivalencies</u> – The Equivalency Subcommittee reported on waivers granted for mentor meetings missed, for a waiver granted for an undergraduate degree, and a request to reenter the program at a higher credentialing level which was accepted based on an essay the candidate wrote at the committee's request.

<u>Forms/Documents: Existing</u> – The RECC Mission Statement will be edited to add "multicultural" in the bullet point with "anti-racist, anti-oppressive."

Ministry To and With Youth

The RECC will engage in an audit of the credentialing program documents with a youth ministry lens.

The committee will invite a credentialed educator with expertise in youth ministry to serve as the credentialed observer for the October 2008 meeting.

<u>Portfolios and Audio-Visual Materials</u> – The committee decided by vote that candidates for the credentialed and masters level must submit their portfolio to the RECP director for feedback and review prior to their meeting with RECC, with two sections submitted well before the meeting at a time to be determined by the director.

GA Workshop: Layleaders' Guide to RE Excellence

The desired outcome of an excellent religious education program is that the young people become lifelong UUs and use UU principles in their young adult lives. Given the complexity, the importance, and what excellence looks like, having a credentialed religious educator and helping them develop those skills is essential. We want at least one ah-ha! moment for each person attending the workshop.

LREDA Professional Day Workshop: Mentoring for Formation

<u>Young Adult Issues</u> – The committee heard a presentation from two young adult DREs, neither currently credentialed, about their experiences and what they have heard about the credentialing program from their contemporaries. Young adults are looking for a career path, and DRE salaries are a huge issue if being a DRE is going to be seen as a career. More young adults are working in religious education, but they are not seeing an increase in young adult congregants.
